Amin Amiri is the founder, funder and CEO of a2e Industries Limited (a2e), a long term value investor, focusing on investing in or acquiring mid-market underperforming industrial companies and 'hyper growth' technology situations. a2e is viewed as a distinctive operator due to its focus, ethos and ethical approach.

Amin is a highly accomplished corporate financier who specialises in wealth creation by 'revitalising' businesses mainly through strategic and operational development of companies. The portfolio of investments in which he has a controlling interest includes manufacturing/industrial companies with aggregate sales and EBITDA of circa £150m and £20.0m, respectively.



He has an enviable track record of creating/enhancing shareholder value for the companies in which he has invested using his own funds. He was viewed to be the 'Entrepreneur's Entrepreneur!' in the prestigious Daily Telegraph Business Club film released in November 2009, and has won many awards and accolades, including 'Insider's Turnaround Team of the Year Award' in 2013.

Amin is a graduate and a Fellow of the Institute of Chartered Accountants in England and Wales and completed an Executive MBA at the prestigious Harvard Business School. He then experienced at first hand the potency of the capital markets in New York, handling corporate finance advisory assignments in the US, South America, Moscow, Belgrade and London.

Amin returned to the UK in 1991 and as head of Grant Thornton Corporate Finance in the North, developed the team in Liverpool, Manchester and Leeds from small beginnings to national recognition and profitability. His innovation and flair in deal making, in the course of completing 200 or so transactions with a value of over £1.5 Billion, earned him a high profile in the UK.
